Citation and Commencement

- 2. "Consolidated Demand Notice" means Assessment of Taxpayers with the use of harmonized demand notice for all Ministries Departments and Agencies for any Tax collectable by the State Internal Revenue Service and any local government council revenues delegated to the service.
- 3. The Chairman shall be:
- (d) an administrator, accountant, or any person with adequate knowledge in Taxation.
- 4. Section 36 (1) of the Yobe State Revenue (Codification) Law 2021 (herein after referred to as the "Principal law) is hereby deleted and replace with a new one to read as:

"To assess collect, account for and enforce payment of the various taxes, non-taxes revenues and laws specified in the schedule to this law including those of Local Government Councils provided that such power is delegated to the

Amendment to Section 52 (1)

- 5. Section 52 (1) (d) of the Yobe State Revenue Codification law 2021 (herein after referred to as the "Principal law) is hereby amended by redrafting the clause to read as:
 - 52 (1) (d) "where practical the Service shall serve a consolidated demand notice as contained in the schedule to this law upon any company or person in whose name a tax is chargeable and if payment is not made within 30 days from the date of the service of such consolidated demand notice, the Service may proceed to enforce payment under this law"

Amendment to Section 60 (1) & (2)

- 6. Section 60 (1) & (2) of the Yobe State Revenue Codification law 2021 (herein after referred to as the Principal Law) is hereby deleted and replace with a new one to read as:
 - s. 60 (1) "Presumptive Turnover Tax shall apply to taxable persons/firms where for all practical purposes their income cannot be ascertained or detailed records and accounts are not kept in such manner as would enable proper assessment of income, a presumptive tax based on a fixed percentage of an annual turnover of businesses stated in schedule one of this Law"
 - (2) "the presumptive tax shall apply to traders, manufacturers, and service providers whose annual sales turnover is below N25 million or threshold stated in section 15 (1) of the VAT Act 1993, as amended."

Amendment to section 70 (Application for license to operate promotional lottery) etc.

- 7. Section 70 of the Yobe State Revenue (Codification) Law referred to as the principal Law is amended by deletion of "N5, 000, 000, 000" and replacement thereof with "N5, 000, 000" to read as:
 - 70. Anybody who desires or wishes to operate any promotional lottery, gaming, casino, sport betting or tombola facility, franchise or agency in the State shall upon payment of a non-refundable application fee of N5, 000, 000 apply in writing for operating license which application shall contain information as the Service shall specify.

Amendment to section 71 (Conditions before issuance of license)

8. Section 71 of the Yobe State Revenue (Codification) Law referred to as the Principal Law is amended by insertion of a new paragraph (f) to read as:

(F) "respect all the provision of Tax Law"

Amendment to section 93 (imposition) of

9. Section 93 (1) (a) of the Yobe State Revenue (Codification) Law referred to as the Principal Law is amended by removing the word **"Provides"** and replacement thereof with **"Enjoys"** to read as:

(a) "Enjoy private education services at all levels"

Amendment to Section 106 (2) 10. Section 106 (2) of the Yobe State Revenue Codification law 2021 (herein after referred to as the Principal Law) is hereby amended by the addition of a proviso under the section to read as follows:

s.106 (2) "Provided that The Service shall collect, recover and pay to the designated account all taxes due to the State Government and all delegated revenues of Local Government Councils in the State under this or any other enactment through an electronic payment platform"

Amendment to Section 108 (1) & (2) **11.** Section 108 (1) & (2) of the Yobe State Revenue Codification law 2021 (herein after referred to as the principal law) is hereby deleted and replace with a new one to read as:

s.108 (1) From the commencement of this law the Service shall be the sole body responsible for the collection of all revenues due to the State and Local Government councils delegated under a written Law.

- (2) the Service shall be responsible for:
- (a) issuance of receipt.
- (b) maintaining records of all revenue collections and remission, and
- (c) issuance of consolidated demand notice.

- 12. Section 110 (1) & (2) of the Yobe State Revenue Codification law 2021 (herein after referred to as the "Principal law") is hereby deleted and replace with a new one to read as:
 - s. 110. (1) Where it appears that a person liable to pay taxes, fees, levies, charges and fins etc. the Services may demand from such person payment of such taxes, fees, levies, charges and fines etc. by serving an assessment thereof in a Consolidated demand notice requesting the payment of the total amount due within thirty (30) days from the service of the demand notice.
 - (2) The Consolidated demand notice shall be in a form stipulated in the schedule to this Law or as may from time to time approved by the relevant tax authority.

Amendment to the Principal Law 13. The Yobe State Revenue (codification) Law referred to as the Principal Law is amended by addition of a new chapter to read as;

CHAPTER XII RADIO AND TELEVISION TAX

Imposition of Radio and Television Tax 14. A Tax is imposed on sales, ownership and usage of any devices or equipment capable of receiving radio and television broadcast content in the State (referred to as Radio and Television Tax).

Device or equipment capable of receiving broadcast

- 15. The devices or equipment capable of receiving radio and television broadcast content include:
 - (a) Satellite broadcast platform;
 - (b) Telecommunication/internet broadcasts platform;
 - (c) Digital set box or similar devise;
 - (d) Motor vehicle/tricycle with broadcast equipment.

Review of rate of Tax

16. The rate of Radio and Television tax which are contained in the schedule to this Law, may be reviewed by the State House of Assembly from time to time.

Deduction and remittance of Tax to the Service

17. (1) All sales, operators or owners of:

- (a) Sales of devices or equipment;
- (b) Satellite broadcast, telecommunication and internet broadcast and digital set box platforms;
- (c) Motor vehicle/tricycle registration and licensing shall:

Deduct all radio and television taxes at the point of licensing, subscription or registration of their services by their customers and promptly remit same to the services.

Failure to deduct and remit Tax

18. Any seller of devise, operator, owner or principal officer of a satellite broadcast, telecommunication/ internet broadcast, vehicle/tricycle registration/licensing and digital set box platform who fails to deduct or deduct but fails to remit to the service the tax imposed in section 6 above shall be guilty of an offence and liable on conviction to a fine of five hundred-thousand-Naira (N500, 000) or imprisonment for a term of at least six (6) months or both.

Amendment to chapters and sections

19. All other chapters and sections are rearranged accordingly.

Amendment to Eight Schedule

- 20. Schedule Eight of Yobe State Revenue (Codification) Law referred to as the Principal Law is amended by:
 - a. Deletion of some revenue codes that appears twice under presumptive Tax collectable by Service as shown in the schedule two to this Law.
 - b. Deletion some codes under Internal Revenue Service and Ministry of Agriculture based on the approved Joint Tax Board rates, as shown in the Schedule three to this Law.
 - c. Transfer of codes from Yobe State Geographic Information Service (YOGIS) to Ministry of Housing and Urban Development, as shown in the schedule four to this Law.
 - d. Review of some rates under Bureau on Public Procurement, Yobe State Television, College of Education and Legal Studies Nguru, College of

Administration, Management and Technology, Water Corporation Agency for Mass Education and Ministry of Agriculture as shown in schedule five to this Law.

- e. Addition of new revenue codes under some Ministries, Department and Agencies, as shown in schedule Six to this Law.
- f. Creation of Rates for the newly established Yobe State Healthcare Inspection and Monitoring Agency as shown in schedule seven to this Law.
